Giving in Illinois: an update

Philanthropy in Illinois has experienced significant growth and changes in funding areas over the last year. This report briefly examines the scale and scope of philanthropy in the state of Illinois as well as the giving patterns of foundations, updating the *Giving in Illinois* publication using fiscal year 2000 data. Data for this report are based on research conducted for the *Directory of Illinois Foundations, 7th edition*, newly released by the Donors Forum of Chicago in October 2002, as well as a representative sample of foundations from the Donors Forum GrantSource database. State-Wide Overview

Giving in Illinois by foundations and corporate giving programs for fiscal year 2000 totaled \$1.57 billion, representing an increase of 27% over fiscal year 1999 giving figures. As the estimated increase of 8% in foundation giving nationally over the same period is much lower, the capture of a larger number of foundations, the collection of a greater percentage of grants data on existing foundations, as well as a growth in giving, contributed to this large increase.

Contributions from individuals increased by almost 19% between 1998 and 2000. In 2000 Illinois taxpayers claimed \$5.9 billion in contributions; total Illinois individual giving is estimated at \$7.1 billion. This figure surpasses the 8% increase in individual giving nationally during the same time.¹

There were 2,496 foundations in Illinois in fiscal year 2000; their combined asset size was approximately \$21 billion. Foundation assets in Illinois increased by 6% between 1999 and 2000, slightly below the national increase of 9%.

The number of foundations in Illinois grew by approximately 11% over the last two years.²

Corporate foundations and giving programs, while only 6% of the total number of Illinois foundations, accounted for 26% of all grants. Private independent foundations awarded over 40% of all grants; family foundations awarded 16% of all grants.

82% of foundations and corporate giving programs in Illinois were located in the Chicago metropolitan region; 42% were headquartered in the city of Chicago. Metro area foundations and corporate giving programs held 96% of all assets and made 95% of all grants in 2000. Within the metro area, the number of foundations increased by 11%, while outside the region, the number of foundations increased by 1.1%.

Outside the metropolitan region, the largest number of foundations and corporate giving programs were located in Winnebago, Peoria, Rock Island, and DeKalb counties. Foundations outside of the Chicago metropolitan region accounted for \$911 million in assets (4% of total Illinois foundation assets) and \$85 million in grants (5% of total grants made by Illinois foundations).





A Closer Look at Philanthropy in Chicago

The following analysis of grant activity in Chicago utilizes grants data from a group of 67 participating foundations and corporate giving programs in the Donors Forum of Chicago GrantSource database. This sample of 11,653 grants totaling \$444 million represents 27% of Illinois grant dollars awarded in 2000.







^{*} Education accounted for the most significant share of total grant dollars (21.4%), replacing Public Affairs, Society Benefit and Human Services, two areas that tied for the highest share of total funding in 1999.

^{*} Human Services led in the number of grants awarded

^{*} Among major subject categories, Environment/Animals declined the most, garnering 14% of grant dollars in 1999 and only 9% in 2000.


^{*} Grant dollars awarded for the purpose of Arts, Culture, Humanities increased from 12% in 1999 to 14% in 2000.








- * Program support represented close to half of all grants awarded, both in terms of number of grants and grant dollars, which is approximately 10% higher than the national average for this type of support.
- * Although 40% of grants awarded were for general operating support, these grants only accounted for about a fourth of total grant dollars awarded. With a median grant amount of \$6 thousand, grants for general operating support were smaller, but greater in number.
- * Capital Support increased from 6% to 7% of grant dollars awarded, though this figure is still less than the national average of 12%. The percentage of grant amount exceeding the percentage of grants awarded indicates that fewer large grants were made in this support category.

The following charts illustrate, for each foundation type, the proportion of funding for their top four areas of giving.










Amount
